

BOISE PUBLIC SCHOOLS INDEPENDENT STUDY PROGRAM

THE INDEPENDENT STUDY PROGRAM SPONSORED BY THE BOISE PUBLIC SCHOOLS IS DESIGNED TO PROVIDE QUALIFIED STUDENTS WITH LEARNING EXPERIENCES WHICH WOULD NOT OTHERWISE BE AVAILABLE TO THEM. WITH PROPER APPROVAL, STUDENTS WHO MEET ANY OF THE CRITERIA LISTED BELOW MAY APPLY FOR ADMISSION TO AN INDEPENDENT STUDY PROGRAM.

Eligibility: To qualify for participation in the Boise District's Independent Study Program, a student must show evidence of fulfilling the following requirements:

1. Have demonstrated outstanding scholastic proficiency in the subject area in which the independent work is to be followed;
2. Have exhibited in the selected subject area a degree of specialized interest which cannot be satisfied through enrollment in a regularly-offered program;
3. Have experienced schedule conflicts which cannot be resolved and which limit the student in his/her legitimate request for a suitable course of studies;
4. Have enrolled in six regularly-scheduled classes.

General Information: The following items of information are offered in an effort to clarify the scope and operation of the Independent Study Program:

1. Students may not elect to follow Independent Study Programs in lieu of or substitution for courses of study which are required to meet the State of Idaho requirements for graduation;
2. A student involving himself/herself in an Independent Study Program must accept the responsibility that such a commitment will not infringe on or interfere with his/her normal or existing schedule if classes;
3. No Independent Study Program will be considered as approved until all parties involved have affixed their signatures to the completed application form;
4. A student must understand and accept that the contracted work must be completed within the time element initially agreed upon. Failure to satisfy any of the originally-stipulated work will render the agreement as void and no credit will be granted to the student nor will any indication of participation in the program be registered on his/her permanent record.
